A RESOLUTION

To ratify the "United Nations Convention on the Elimination of all Forms of Discrimination Against Women" (December, 1979), with reservations.

- 1 WHEREAS, the Convention on the Elimination of all Forms of
- 2 Discrimination Against Women ("CEDAW") was adopted by the United
- 3 Nations General Assembly in December, 1979, and entered into force
- 4 in September, 1981; and
- 5 WHEREAS, since joining the United Nations in 1991, the
- 6 Government of the Federated States of Micronesia has consistently
- 7 taken positive action on issues affecting human rights; and
- 8 WHEREAS, Article IV, section 4 of the Constitution of the
- 9 Federated States of Micronesia guarantees the equal protection of
- 10 the laws to all citizens, regardless of gender; and
- 11 WHEREAS, discrimination against women violates the principles
- 12 of equal protection of the laws, and respect for human dignity; is
- 13 an obstacle to the participation of women on equal terms with men
- 14 in the political, social, economic and cultural life of their
- 15 countries; hampers the prosperity of society and the family, and
- 16 makes more difficult the full development of the potentialities of
- 17 women in the service of their countries and of humanity; and
- 18 WHEREAS, the Federated States of Micronesia continues to be
- 19 committed to human equality; and
- 20 WHEREAS, the Convention on the Elimination of all Forms of
- 21 Discrimination Against Women condemns all forms of discrimination

- 1 against women, and parties to the Convention agree to pursue
- 2 without delay a policy eliminating discrimination against women;
- 3 and
- 4 WHEREAS, the Federated States of Micronesia supports the
- 5 global effort to end all forms of discrimination against women;
- 6 now, therefore,
- 7 BE IT RESOLVED by the Thirteenth Congress of the Federated
- 8 States of Micronesia, First Regular Session, 2003, that pursuant
- 9 to section 2(b) of Article IX of the Constitution of the Federated
- 10 States of Micronesia, and subject to the reservations specified
- 11 below, the Congress hereby ratifies the "United Nations Convention
- 12 on the Elimination of all Forms of Discrimination Against Women"
- 13 (December, 1979);
- 14 BE IT FURTHER RESOLVED that the ratification of this
- 15 Convention is subject to the following reservations:
- 1. The Government of the Federated States of Micronesia
- 17 advises that it is not at present in a position to take the
- 18 measures either required by Article 11(1)d of the Convention to
- 19 enact comparable worth legislation, or by Article 11(2)b to enact
- 20 maternity leave with pay or with comparable social benefits
- 21 throughout the nation;
- 22 2. The Government of the Federated States of Micronesia,
- 23 in its capacity as trustee of the heritage of diversity within its
- 24 States under Article V of its Constitution, reserves the right not
- 25 to apply the provisions of Articles 2(f), 5, and 16 to the
