

A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by amending sections 1 and 5 thereof to reallocate certain funds appropriated for projects and programs in the State of Chuuk, to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 9-100, as amended by
2 Public Laws Nos. 9-104, 9-129, 9-150, 10-1, 10-116, 12-62, 12-78
3 and 13-14, is hereby further amended to read as follows:

4 "Section 1. The sum of \$5,350,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 1997, for the
8 purpose of funding the infrastructure, social and
9 economic development and other needs of the State of
10 Chuuk. The funds appropriated by this section shall be
11 apportioned as follows:

- 12 (1) Statewide projects and programs
- 13 (a) Road construction equipment
- 14 and other State needs\$ 188,153
- 15 (b) Landing craft acquisition and
- 16 other needs 199,077
- 17 (c) Statewide grants: 87,000

13 Section 2. Section 5 of Public Law No. 9-100, as amended
 14 by Public Laws Nos. 9-104, 9-137, 10-117 and 13-14, is hereby
 15 further amended to read as follows:

16 "Section 5. Allotment and management of funds and lapse
 17 date.

18 (1) All funds appropriated by this act shall be
 19 allotted, managed, administered, and accounted for
 20 in accordance with applicable law, including, but
 21 not limited to, the Financial Management Act of
 22 1979. The allottee of the funds appropriated under
 23 subsection (1) of section 1 of this act shall be the
 24 Chuuk State Commission on Improvement Projects. The
 25 allottee of the funds appropriated under subsection

1 (2) (a), (2) (b), (2) (c) and (2) (d) of section 1 of
2 this act shall be the Toleisom Authority. The
3 allottees of the funds appropriated under subsection
4 (2) (e) and (2) (f) of section 1 of this act shall be
5 the mayors of the respective municipalities. The
6 allottee of the funds appropriated under subsection
7 (2) (g), (2) (h) and (2) (i) of section 1 of this act
8 shall be the mayor of Polle Municipality. The
9 allottee of the funds appropriated under subsection
10 (3) of section 1 of this act shall be the Southern
11 Namoneas Development Authority. The allottee of the
12 funds appropriated under subsections (4) and (8) of
13 section 1 of this act shall be the Northern Namoneas
14 Development Authority. The allottee of the funds
15 appropriated under subsection (5) of section 1 of
16 this act shall be the Mortlock Development
17 Authority. The allottee of the funds appropriated
18 under subsection (6) of section 1 of this act shall
19 be the [~~Pattiw Development Authority~~] Executive
20 Director of the Chuuk State Commission on
21 Improvement Projects. The allottee of the funds
22 appropriated under subsection (7) of section 1 and
23 subsection (2) of section 4 of this act shall be the
24 Speaker of the Congress of the Federated States of
25 Micronesia or the Speaker's designee. The allottee

1 of the funds appropriated under subsection (2) of
2 section 2 of this act shall be the Chairman of the
3 Kosrae Utilities Authority, and the allottee of the
4 funds appropriated under subsection (9) of section 2
5 of this act shall be the Governor of the State of
6 Kosrae. The allottee of the funds appropriated
7 under subsection (2)(a) and (2)(b) of section 3 of
8 this act shall be the Pohnpei Visitor's Bureau. The
9 allottee of funds appropriated under subsections (1)
10 and (3) of section 4 of this act shall be the
11 Governor of the State of Yap. The allottee of all
12 other funds appropriated by this act shall be the
13 President of the Federated States of Micronesia or
14 the President's designee. The allottees shall be
15 responsible for ensuring that these funds, or so
16 much thereof as may be necessary, are used solely
17 for the purpose specified in this act, and that no
18 obligations are incurred in excess of the sum
19 appropriated. The authority of the allottees to
20 obligate funds appropriated by this act shall lapse
21 on September 30, [2003] 2004 [~~except that the~~
22 ~~authority of the allottee to obligate funds~~
23 ~~appropriated by subsection (1)(c) of section 1 of~~
24 ~~this act shall lapse on September 30, 2004.~~"] "

1 Section 3. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
