## A BILL FOR AN ACT

To further amend Public Law No. 12-36, as amended, by amending section 1 thereof to designate the uses of certain funds appropriated therein for programs and projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 1 of Public Law No. 12-36, as amended by
- 2 Public Laws Nos. 12-67 and 13-52, is hereby further amended to
- 3 read as follows:
- 4 "Section 1. All sums directly or indirectly received as
- 5 the FSM's portion of the revenue sharing component of
- 6 payments by the State for wages and salaries tax,
- 7 penalties and interest, in an amount not to exceed
- 8 \$941,164, are hereby appropriated from the General Fund
- 9 of the Federated States of Micronesia for the fiscal
- 10 year ending September 30, 2002, for programs and project
- grants in the State of Chuuk, including the following:
- 12 Nema municipality grant [purchase of engine for MS
- 13 <u>Lien Arani</u>] <u>Municipal operations or purchase/</u>
- 14 <u>Lease of land</u> ......\$ 25,000"
- 15 Section 2. Section 7 of Public Law No. 12-36, as amended by
- 16 Public Law No. 12-67, is hereby further amended to read as
- 17 follows:
- 18 "Section 7. All funds appropriated by this act shall be
- 19 allotted, managed, administered, and accounted for in

1 accordance with applicable law, including, but not 2 limited to, the Financial Management Act of 1979. 3 allottee of all funds appropriated by sections 3, 4, 5 and 6 of this act shall be the President of the 4 5 Federated States of Micronesia or the President's designee, except that the allottee of all funds 6 7 appropriated by section 6(3) of this act shall be the 8 Governor of the State of Yap, and the allottee of all 9 funds appropriated by section 6(5) of this act shall be 10 the Chuuk State Commission on Improvement Projects. 11 allottee of all funds appropriated by section 1 of this 12 act shall be the Chuuk State Commission on Improvement 13 Projects; except that the allottee of the funds 14 appropriated for Nema Municipality shall be the 15 Executive Director of the Mortlocks Development 16 Commission. The allottee of all funds appropriated by 17 section 2 of this act shall be the Governor of Pohnpei 18 State. The allottees shall be responsible for ensuring 19 that these funds, or so much thereof as may be 20 necessary, are used solely for the purpose specified in 21 this act, and that no obligations are incurred in excess 22 of the sum appropriated. The authority of the allottees 23 to obligate funds appropriated by this act shall not 24 lapse."
