A BILL FOR AN ACT

To further amend Public Law No. 9-095, as amended, by amending section 1 thereof, to deposit certain funds appropriated therein into the fund entitled "Public Projects for Chuuk Election District No. 3" within the General Fund of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
