A BILL FOR AN ACT

To further amend Public Law No. 9-27, as amended, by amending sections 2 and 5 thereof, to change the use and allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA

- 1 Section 1. Section 2 of Public Law No. 9-27 is hereby
- 2 amended to read as follows:

3 "Section 2. The sum of \$200,000, or so much thereof as 4 may be necessary, is hereby appropriated from the 5 General Fund of the Federated States of Micronesia for 6 the fiscal year ending September 30, 1995, for projects 7 in [pharmaceutical supplies, lab and dental equipment, 8 and referral programs in] the State of Pohnpei as 9 follows: (1) Completed Projects\$ 10 50,000 11 (2) ED #2 Road Paving 80,000 12 (3) Madolenihmw/Kitti Agriculture Fair ... 20,000

14 (5) Project Management ED #2 25,000"

Section 2. Section 5 of Public Law No. 9-027, as amended by

16 Public Laws Nos. 10-65, 12-28, 12-42 and 13-03, is hereby further 17 amended to read as follows:

18 "Section 5. <u>Allotment and management of funds and lapse</u> 19 <u>date</u>.

1 (1) All funds appropriated by this act shall be 2 allotted, managed, administered, and accounted for in accordance with applicable law, including, but not 3 4 limited to, the Financial Management Act of 1979. The 5 allottee of the funds appropriated under subsection (1) of section 1 of this act shall be the Director of Health 6 7 Services, Chuuk State. The allottee of the funds 8 appropriated under subsection (2) of section 1 of this 9 act shall be the Mayor of Polle Municipality. The allottee of the funds appropriated under subsections (3) 10 and (5) of section 1 of this act shall be the Chuuk 11 12 State Commission on Improvement Projects. The allottee 13 of the funds appropriated under subsection (4) of 14 section 1 of this act shall be the Northern Namoneas 15 Development 16 Authority. The allottee of the funds appropriated under subsection (6) of section 1 of this act shall be the 17 Pattiw Development Authority. The allottee of the funds 18 19 appropriated under section 2 of this act shall be the 20 [Governor of Pohnpei State] President of the Federated States of Micronesia. The allottee of the funds 21 22 appropriated under section 3 of this act shall be the 23 Governor of Yap State. The allottee of the funds 24 appropriated under section 4 of this act shall be the 2.5 Governor of Kosrae State. The allottees shall be

1	responsible for ensuring that these funds, or so much
2	thereof as may be necessary, are used solely for the
3	purpose specified in this act, and that no obligations
4	are incurred in excess of the sum appropriated.
5	(2) All funds appropriated herein shall not lapse
6	until fully expended."
7	Section 3. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its
9	becoming law without such approval.
