A BILL FOR AN ACT

To further amend Public Law No. 9-52, as amended, to change the uses of certain funds appropriated for the purpose of funding public projects in Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

| 19 | (1) All funds appropriated by this act shall be |
| 20 | allotted, managed, administered and accounted for in |
| 21 | accordance with applicable law, including, but not |
| 22 | limited to, the Financial Management Act of 1979. The |
| 23 | allottee of the funds appropriated under subsection (1) |
| 24 | of section 1 of this act shall be the Chuuk State |
| 25 | Commission on Improvement Projects. The allottee of the |

funds appropriated under subsection (2) of section 1 of this act shall be the Executive Director of the Chuuk Housing Authority. The allottee of the funds appropriated under subsections (3), (4) and (5) of section 1 of this act shall be the Executive Director of the Chuuk State Commission on Improvement Projects. allottee of the funds appropriated under subsection (6) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (7) of section 1 of this act shall be the Chuuk State Commission on Improvement Projects. The allottee of the funds appropriated under subsections (1)(b)(i) and (1)(b)(iii) of section 2 of this act shall be the National Planner of the Federated States of Micronesia. The allottee of the funds appropriated under subsections (1)(b)(ii) and (1)(b)(v) of section 2 of this act shall be the Chief Magistrate of Sokehs. The allottee of the funds appropriated under subsections (1)(b)(iv) of section 2 of this act shall be the National Planner of the Federated States of Micronesia. The allottee of the funds appropriated under subsection (1)(c) of section 2 of this act shall be the Mayor of Kolonia Town. The allottee of the funds appropriated under subsection (1)(d) of section 2 of this act shall be President of the Federated States of

Micronesia or his designee. The allottee of the funds appropriated under subsection (1)(e) of section 2 of this act shall be the Chief Magistrate of Nukuoro. The allottee of the funds appropriated under subsection (1) (f) of section 2 of this act shall be the Pohnpei Port Authority. The allottee of the funds appropriated under subsections (1)(a) and (3) of section 2 and subsections (2) and (3) of section 3 of this act shall be the President of the Federated States of Micronesia or his designee, except that the allottee of the funds appropriated under subsections (3)(a), (3)(b), (3)(c) and (3)(d) of section 2 of this act shall be the Pohnpei Transportation Authority. The allottee of the funds appropriated under subsections (1) and (4) of section 3 of this act shall be the Governor of the State of Kosrae or his designee. The allottee of the funds appropriated under subsections (5)(a), (7) and (8) of section 3 of this act shall be the Mayor of Lelu Municipality. The allottee of the funds appropriated under subsection (5) (b) of section 3 of this act shall be the Mayor of Tafunsak Municipality. The allottee of the funds appropriated under subsection (5)(c) of section 3 of this act shall be the Mayor of Utwe Municipality. The allottee of the funds appropriated under subsection (5)(d) of section 3 of this act shall be the Mayor of

Malem Municipality. The allottee of the funds 1 2 appropriated under subsection (6) of section 3 of this 3 act shall be the Speaker of the Congress of the 4 Federated States of Micronesia or his designee. 5 allottee of the funds appropriated under subsection (6) 6 of section 4 of this act shall be the Mayor of Rull 7 Municipality. Except for the funds appropriated under subsection (15), for which the allottee shall be the 8 9 President, [\frac{1}{2}] the allottee of the funds appropriated 10 under the other subsections of section 4 of this act 11 shall be the Governor of the State of Yap or his designee. The allottees of funds apportioned under 12 subsection (1) of section 2 of this act shall not 13 14 obligate or expend any of said funds for travel. allottees shall be responsible for ensuring that these 15 16 funds, or so much thereof as may be necessary, are used 17 solely for the purpose specified in this act, and that 18 no obligations are incurred in excess of the sum 19 appropriated.

20 (2) The authority of the allottees to obligate funds
21 appropriated by this act shall not lapse."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
