## A BILL FOR AN ACT

To further amend title 40 of the Code of the Federated States of Micronesia, known as the College of Micronesia - FSM Act of 1992, as amended, by amending sections 707 and 708 with respect to the term of members of the Board of Regents, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 707 of title 40 of the Code of the
- 2 Federated States of Micronesia, as amended by Public Law No. 8-
- 3 144, is amended to read as follows:
- 4 "Section 707. Board of Regents; Initial terms of 5 office. At the initial Board meeting, the four members 6 of the Board representing their respective States shall 7 draw lots in order to ascertain their terms of office. Two States shall have an initial two-year term and two 8 9 States shall have an initial three-year term. After the 10 initial terms, the terms of the respective State members shall be as provided in section 708 of this chapter. 11 The initial term of office of the remaining Board member 12 13 shall be as provided in section 708 of this chapter. 14 Members of the Board may serve beyond the expiration 15 date of their initial terms [until their successors have 16 been appointed.] the first meeting of the Board

following the appointment of that member's successor;

except that no member shall remain in office in this

3	Section 2. Section 708 of title 40 of the Code of the
4	Federated States of Micronesia, as amended by Public Law No. 8-
5	144, is amended to read as follows:
6	"Section 708. Board of Regents; Terms of office.
7	The terms of office for the members of the Board shall
8	be as follows:
9	(1) The member representing the National Government
10	shall serve for a term of three years and shall not
11	serve more than two consecutive terms.
12	(2) The members representing their respective States
13	shall serve for a term of three years and shall not
14	serve for more than two consecutive terms.
15	(3) Members of the Board may serve beyond the
16	expiration date of their terms until [their successors
17	have been appointed.] the first meeting of the Board
18	following the appointment of that member's successor;
19	except that no member shall remain in office in this
20	manner for longer than one year after the end of his
21	term. The initial terms of members of the Board shall
22	be counted towards the aforementioned limitation of
23	terms."
