## A BILL FOR AN ACT

To further amend Section 1 of Public Law No. 14-67 in order to make technical changes, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1 of Public Law No. 14-67 is hereby amended to read 2 as follows:

"Section 1. The sum of \$2.1 million, or so much thereof
as may be necessary, is hereby appropriated from the
General Fund of the Federated States of Micronesia for
the fiscal year ending September 30, 2006 for projects
and programs in each state of the Federated States of
Micronesia. The funds appropriated under section 1 of
this act shall be apportioned on the basis of \$150,000
per member of Congress as follows:
