BE I	T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 8 of Public Law No. 14-21, as amended by
2	Public Laws Nos. $14-50$ and $14-70$, is hereby further amended to
3	read as follows:
4	"Section 8. Grants, Subsidies and Contributions. The
5	sum of \$3,070,766, or so much thereof as may be
6	necessary, is hereby appropriated from the General Fund
7	of the Federated States of Micronesia for the fiscal
8	year ending September 30, 2006, for the following
9	grants, subsidies and contributions during fiscal year
10	2006. The sum appropriated by this section shall be
11	apportioned as follows:

Section 12 of Public Law No. 14-21 is hereby further amended to read as follows: 10 "Section 12. Allotment and management of funds and 11 lapse date. 12 (1) General Provisions. 13 (a) All Funds appropriated by this act shall be allotted, managed, administered and accounted for in 14 15 accordance with applicable law, including, but not 16 limited to, the Financial Management Act of 1979 and the 17 amended compact of Free Association between the United States Government and the Government of the Federated 18 19 States of Micronesia and its related agreements. 20 (b) The allottees shall be responsible for 21 ensuring that these funds, or so much thereof as may be 22 necessary, are used solely for the purpose specified in 23 this act, and that no obligations are incurred in excess of the sum appropriated. 24 25 (2) <u>Allottees</u>. The allottee of the funds appropriated

1	by this act are as follows:
2	(a) Section 2 - the allottee of these funds shall
3	be the President of the Federated States of Micronesia;
4	(b) Section 3 - the allottee of these funds shall
5	be the Speaker of the Congress of the Federated States
6	of Micronesia;
7	(c) Section 4 - the allottee of these funds shall
8	be the Chief Justice of the Supreme Court of the
9	Federated States of Micronesia;
10	(d) Section 5 - the allottee of these funds shall
11	be the Public Auditor of the Federated States of
12	Micronesia;
13	(e) Sections 6 through 9 - the allottee of these
14	funds shall be the President of the Federated States of
15	Micronesia, EXCEPT That for the following subsections of
16	sections 8 through 9 of this act:
17	(i) section 8 subsection (7)(a) through (c)
18	- the allottee of these funds shall be the Chief Justice
19	of the respective state;
20	(ii) section 8 subsection (7)(d) - the
21	allottee of these funds shall be the Chief Justice of
22	the State of Yap, EXCEPT the Public Defender of the
23	Federated States of Micronesia shall be the allottee for
24	the \$15,000 appropriated for scholarships for Yap
25	students enrolled in law school;

1	(iii) section 8 subsection (7)(e) - the
2	allottee of these funds shall be the Chief Justice of
3	the Supreme Court of the Federated States of Micronesia;
4	and
5	(iv) section $9(1)(a)$ through (g) - the
6	allottee of these funds shall be the President of the
7	College of Micronesia-FSM.
8	(3) Lapse Date. The authority of the allottee to
9	obligate funds appropriated by this act shall lapse as
10	of September 30. 2006, EXCEPT that the funds
11	appropriated under <u>subsection 8(7)(g) of this act for</u>
12	purposes of feeding prisoners and making renovations at
13	the Chuuk Department of Public Safety prison shall not
14	lapse until September 30, 2007, and the funds
15	appropriated under subsection 8(3)(m), subsection
16	8(7) (m) and section 9 of the this act shall not lapse,
17	EXCEPT the funds appropriated under subsections 9(1)(b),
18	9(1)(c), $9(1)(f)$ and $9(10)(a)$ shall lapse as of March
19	31, 2007."

23	Section 3. This act shall become law upon approval by the
24	President of the Federated States of Micronesia or upon its
