## A BILL FOR AN ACT

To further amend Public Law No. 12-12, as amended, by amending section 13 thereof, to deposit certain funds appropriated for Chuuk Election District No. 5 in the fund entitled "Public Projects for Chuuk Election District No.5" within the General Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 13 of Public Law No. 12-12, as amended by
 Public Laws Nos. 12-21, 12-24, 12-35, 12-48, 13-18 and 14-7, is hereby
 further amended to read as follows:

"Section 13. Capital and Human Resource Development. 4 The sum of \$10,915,200, or so much thereof as may be 5 necessary, is hereby appropriated from the General Fund of 6 7 the Federated States of Micronesia for the fiscal year ending September 30, 2002, for capital improvement, 8 9 development programs and projects and human resource 10 development. Of the total funds appropriated under this 11 section, \$2,737,926 shall be deemed to come from the capital 12 account funds available under section 211 of the Compact of Free Association, and \$1,387,700 from the funds available 13 14 under section 216(a)(3) of the Compact of Free Association. 15 The sum appropriated under this section shall be apportioned 16 as follows:
