## AN ACT

To further amend Public Law No. 13-57, as amended, by amending Section 1 thereof to authorize the use of \$500,000 to fund various consultants required for private sector development, tax reform efforts, and for other purposes.

BE IN ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- "Section 1. <u>Authorization</u>. The President of the
  Federated States of Micronesia is hereby authorized to
  utilize a portion of the proceeds of the first tranche
  of the FSM National Government's portion of Private
  Sector Development (PSD) Program loan from the Asian
  Development Bank:
  - (a) in an amount not to exceed \$180,000 for the Division of Customs and Tax Administration, within the Department of Finance and Administration, to employ a certified tax accountant and a lawyer specializing in taxation law for the purpose of improving taxation collection and administration within the Division of Customs and Tax Administration;
