PUBLIC LAW NO. 14-84

AN ACT

To reappropriate the sum of \$1,325,623 or so much thereof as is necessary, from lapsed fund as of June 30, 2006 in the General Fund of the Federated States of Micronesia for the States of Kosrae and Chuuk, for the purpose of funding public projects and social programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$450,552 or so much thereof as may be necessary that lapsed as of June 30, 2006 as required by Public 2 Law No. 14-35 from Public Laws Nos. 7-107, 8-115, 8-19, 9-052, 9-3 095, 10-120, 10-143, 11-36 and 11-59 for the State of Kosrae, is 4 5 hereby reappropriated from the General Fund of the Federated 6 States of Micronesia for the fiscal year ending September 30, 2006, for the purpose of funding infrastructure projects, 7 8 economic development projects and social programs in the State of 9 Kosrae.

Section 8. The sum of \$31,107 or so much thereof as may be necessary that lapsed as of June 30, 2006 or as required by Public Law No. 14-35 from Public Laws Nos. 8-134, 11-27 and 11-59 for Election District No. 1 in Chuuk State, is hereby reappropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2006, for the purpose of funding projects and social programs in Election District No. 1 in Chuuk State and shall be apportioned as follows:

allotted, managed, administered, and accounted for in accordance 1 2 with applicable law, including, but not limited to, the Financial 3 Management Act of 1979. The allottee of the funds appropriated 4 in Section 1 of this Act shall be the President of the Federated States of Micronesia or the President's designee. The allottee 5 of the funds appropriated in Sections 2, 3 and 4 of this Act 6 7 shall be the Chuuk State Commission on Improvement Project. The 8 allottee shall be responsible for ensuring that these funds, or 9 so much thereof as may be necessary, are used solely for the 10 purpose specified in this act, and that no obligations are 11 incurred in excess of the sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall lapse 12 13 as of September 30, 2008. 14 Section 10. This act shall become law upon approval by the 15 President of the Federated States of Micronesia or upon its becoming law without such approval. 16 17
