

A BILL FOR AN ACT

To appropriate the sum of \$421,100 from the General Fund of the Federated States of Micronesia for the purpose of funding public projects and social programs in each of the States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose - a certain amount of project  
2 appropriations lapsed on September 2006. The purpose of this bill  
3 is to appropriate from the general fund a corresponding amount.  
4 The intend is similar to extending the lapse date of the  
5 appropriations.

6 Section 2. The sum of \$421,110, is hereby appropriated from  
7 the General Fund of the Federated States of Micronesia for the  
8 fiscal year ending September 30, 2007 for the purpose of funding  
9 public projects and social programs in the States of Chuuk,  
10 Kosrae, Pohnpei and Yap. The funds appropriated under section 1  
11 of this act shall be apportioned as follow:

17 Section 3. All funds appropriated by this act shall be  
18 allotted, managed, administered, and accounted for in accordance  
19 with applicable law, including, but not limited to, the Financial  
20 Management Act of 1979. The allottee of the funds appropriated  
21 in subsection 1 (a) of Section 1 of this Act shall be the  
22 Governor of Yap State, PROVIDED HOWEVER, that the funding for  
23 subsection 1(a) of Section 1 of this Act shall not be expended  
24 until the allottee certifies that the Gargey area shall not be  
25 used for commercial activities. The allottee of the funds

1 appropriated in subsection 2 of Section 1 of this Act shall be  
2 the Chuuk State Commission on Improvement Project (CSCIP). The  
3 allottee of funds appropriated in subsections 3 and 4 of Section  
4 1 of this Act shall be the President of the Federated States of  
5 Micronesia or his designee. The allottee shall be responsible  
6 for ensuring that these funds, or so much thereof as may be  
7 necessary, are used solely for the purpose specified in this act,  
8 and that no obligations are incurred in excess of the sum  
9 appropriated. The authority of the allottee to obligate funds  
10 appropriated by this act shall not lapse.

11 Section 4. This act shall become law upon approval by the  
12 President of the Federated States of Micronesia or upon its  
13 becoming law without such approval.
