

AN ACT

To further amend Sections 1 and 2 of Public Law No. 14-67, as amended, to change the use and allottee of certain funds previously appropriated for social projects and programs in the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 14-67, as amended by
2 Public Laws Nos. 14-72, 14-82 and 14-91 is hereby further amended
3 to read as follows:

4 "Section 1. The sum of \$2.1 million, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2006 for projects
8 and programs in each state of the Federated States of
9 Micronesia. The funds appropriated under section 1 of
10 this act shall be apportioned on the basis of \$150,000
11 per member of Congress as follows:

3 Section 2. Section 2 of Public Law No. 14-67, as amended by
 4 Public Laws Nos. 14-72 and 14-82, is hereby further amended to
 5 read as follows:

6 "Section 2. Allotment and management of funds and lapse
 7 date. All funds appropriated by this act shall be
 8 allotted, managed, administered and accounted for in
 9 accordance with applicable laws, including, but not
 10 limited to, the Financial Management Act of 1979 and the
 11 amended Compact of Free Association between the United
 12 States Government and the Government of the Federated
 13 States of Micronesia and its related agreements. The
 14 allottee shall be responsible for ensuring that these
 15 funds, or so much thereof as may be necessary, are used
 16 solely for the purpose specified in this act, and that
 17 no obligations are incurred in excess of the sum
 18 appropriated. The allottee of the funds appropriated
 19 under subsections (4) (a), (c), (d) and (f) of section 1 of
 20 this act shall be the Chuuk State Commission on
 21 Improvement Project. The allottee of the funds
 22 appropriated under subsection (4) (b) of section 1 of
 23 this act shall be the Mortlocks Development Commission.
 24 The allottee of funds appropriated under subsection
 25 (4) (e) of section 1 of this act shall be the Mayor of
 26 Polle. The allottee of funds appropriated under

1 subsections 1, 2 and 3 of Section 1 of this act shall be
2 the President of the Federated States of Micronesia
3 except that the allottee of funds appropriated under
4 subsections (2)(b), (2)(c), 2(d) and (2)(f) of Section 1
5 of this act shall be the Governor of the State of Yap.
6 The authority of the allottee to obligate funds
7 appropriated by this act shall not lapse."
