A BILL FOR AN ACT

To further amend Public Law No. 14-84, as amended, by amending sections 4 and 9 thereof, to change the use and lapse date of certain funds previously appropriated to fund public projects and social programs in the State of Yap, and for other purposes.

21	Public Laws Nos. 14-94 and 15-13, is hereby further amended to

23	"Section 9. All funds appropriated by this act shall be			
24	allotted, managed, administered, and accounted for in			
25	accordance with applicable law, including, but not			
26	limited to, the Financial Management Act of 1979. The			

1 allottee of the funds appropriated in Section 1 of this 2 Act shall be the President of the Federated States of Micronesia or the President's designee, PROVIDED THAT 3 4 the allottee of funds appropriated in subsection (1) (f) 5 of Section 1 of this Act shall be the Governor of the State of Kosrae. The allottee of the funds appropriated 6 7 in Sections 2, 3, and 4 of this Act shall be the Chuuk 8 State Commission on Improvement Project. The allottee shall be responsible for ensuring that these funds, or 9 10 so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no 11 12 obligations are incurred in excess of the sum 13 appropriated. The authority of the allottee to obligate funds appropriated by this Act shall lapse as of 14 [September 30, 2008] September 30, 2009." 15 16 Section 3.
