A BILL FOR AN ACT

To appropriate \$1,750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, for the purpose of funding public projects and social programs in the States of Chuuk, Yap, Pohnpei and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Shall read as follows: To appropriate the sum of \$1,750,000 from the General Fund of the Federated States of 2 Micronesia for the fiscal year ending September 30, 2009, for the 3 purpose of funding public projects and social programs in the 4 States of Chuuk, Yap, Pohnpei and Kosrae; and for other purposes. 5 6 The sum appropriated herein shall be apportioned as follows: 7 (1) <u>State of Kosrae</u>\$ 250,000 8 (a) Kosrae State At-Large social 9 programs and public projects 125,000 10 (b) Election District No. 1 social programs and public projects 125,000 11 12 (2) State of Yap 250,000 13 (a) Yap State At-Large social programs and public projects 125,000 14 15 (b) Election District No. 1 social 16 programs and public projects 125,000 17 (3) State of Pohnpei 500,000 18 (a) Pohnpei At-Large social 19 programs and public projects\$ 125,000

20	(1) <u>General Provisions</u> .
21	(a) All funds appropriated by this act shall be
22	allotted, managed, administered and accounted for in accordance
23	with applicable law, including, but not limited to, the Financial
24	Management Act of 1979 and the amended Compact of Free Association
25	between the United States Government and the Government of the
23 24	with applicable law, including, but not limited to, the Financial Management Act of 1979 and the amended Compact of Free Association

1 Federated States of Micronesia and its related agreements. 2 (b) The allottees shall be responsible for 3 ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, 4 5 and that no obligations are incurred in excess of the sum 6 appropriated. 7 (2) <u>Allottees</u>. The allottee of the funds appropriated 8 by this act are as follows: 9 (a) Section 1 - the allottee of these funds shall 10 be the President of the Federated States of Micronesia or his 11 designee; 12 (b) Section 2 - the allottee of these funds shall 13 be the Governor of Yap State or his designee; 14 (c) Section 3 - the allottee of these funds shall be the President of the Federated States of Micronesia; 15 16 (d) Section 4 - the allottee of these funds shall 17 be the Chuuk State Commission on Improvement Projects; Lapse Date. The authority of the allottee to obligate 18 19 funds appropriated by this act shall not lapse until fully 20 expended. 21 22 23 24 25 Section 3. This act shall become law upon approval by the
