A BILL FOR AN ACT

To amend sections 103 and 104 of title 36 of the Code of the Federated States of Micronesia; and for other purposes.

1 Section 1. Section 103, title 36 of the FSM Code is hereby amended to read as follows: "Section 103. Application for charter - Article of 3 Incorporation. 4 5 (1) An association of persons seeking a charter as a 6 corporation shall submit for approval of the President 7 of the Federated States of Micronesia, or his designee, 8 articles of incorporation which shall provide as least 9 the following information: 10 (a) proposed name of the corporation; 11 (b) principal office or place of business; 12 (c) proposed duration; 13 (d) purposes; 14 (e) powers; 15 (f) capitalization; 16 (q) names of incorporations, which shall be one 17 or more; (h) number of directors, which [shall not be not 18 19 less than three] shall be one or more, and proposed 20 officers;

(i) name(s) of director(s) and officers to serve

(j) provisions of management, if any; 3 (k) provisions for voting by members; 4 (1) provisions for shareholding, if any 5 (m) disposition of financial surplus; (n) provisions for liquidation; 6 7 (o) provisions for amendment of articles of 8 incorporation. (2) An affidavit shall be submitted to the Office of 9 10 the Registrar by the President and Secretary of the 11 corporation as named in the articles of incorporation 12 not later than sixty (60) days from the date of receipt 13 of the certificate of incorporation. The affidavit shall be notarized by a duly authorized FSM notary or by 14 a duly authorized notary from any country that has 15 16 diplomatic relations with the FSM. 17 (3) Any other document(s) that require notarization shall be done by a duly authorized FSM notary or by a 18 19 duly authorized notary from any country that has 20 diplomatic relations with the FSM." Section 2. Section 104, title 35 of FSM Code is hereby 21 amended to read as follows: 22 23 "Section 104. Application for charter - By laws. 24 addition to articles of incorporation, persons seeking a 25 charter as a corporation [shall] may, at the discretion
