## A BILL FOR AN ACT

To further amend Section 3 of Public Law No. 15-11 to change the use of funds previously appropriated therein from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, to provide funding for the operation of the Legislative Branch of the National Government of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 3 of Public Law No. 15-11, as amended, by
- 2 Public Laws No. 15-26, 15-43, and 15-55 is hereby further amended
- 3 to read as follows:
- 4 "Section 3. Operating Expenses of the Legislative
- 5 Branch. The sum of \$3,073,003 or so much thereof as may
- 6 be necessary, is hereby appropriated from the General
- 7 Fund of the Federated States of Micronesia for the
- 8 fiscal year ending September 30, 2009, for the
- 9 operations of the Legislative Branch of the National
- 10 Government during fiscal year 2009. The sum
- appropriated by this section shall be apportioned as
- 12 follows:
- 13 (1) <u>Speaker and Members</u>.
- \$1,412,771 or so much thereof as may be necessary, for
- the operations of the Office of the Speaker and Members
- of the Congress of the Federated States of Micronesia
- during fiscal year 2009. The sum appropriated herein
- shall be apportioned as follows:
