## A BILL FOR AN ACT

To further amend title 54 of the Code of the Federated States of Micronesia, as amended, by amending of section 221 thereof, as amended by Public Law No. 13-60, to suspend collection of import duties on gasoline and diesel fuel until September 30, 2010, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 221 of title 54 of the Code of the
- 2 Federated States of Micronesia, as amended by Public Law No. 13-
- 3 60, is hereby further amended to read as follows:
- 4 "Section 221. Levy and rates.
- 5 The following import duties are hereby levied on all
- 6 products specified herein which are imported into the
- 7 FSM:
- 8 (1) cigarettes, at the rate of \$0.025 per cigarette,
- 9 provided that this rate shall increase by \$0.005 per
- 10 cigarette on January 1 of each of the years 2007, 2009,
- 2011, 2013 and 2015;
- 12 (2) tobacco, other than cigarettes, at the rate of
- 13 fifty percent ad valorem;
- 14 (3) perfumery, cosmetics, and toiletries, including
- 15 cologne and other toilet waters, articles of perfumery,
- whether in sachets or otherwise, and all preparations
- used as applications to the hair or skin, lipsticks,
- 18 pomades, powders, and other toilet preparations not
- 19 having medicinal properties, at the rate of twenty five

1 percent ad valorem; 2 (4) soft drinks, drink mixes, drink preparations, 3 coffee, tea, and nonalcoholic beverages, at the rate of twenty five percent ad valorem, provided, however, that 4 5 any beverage having a fruit juice content of twenty five percent or more by volume shall be at the rate of three 6 7 percent ad valorem; (5) beer and malt beverages, at the rate of \$0.25 per 8 9 12 fluid ounces; 10 (6) distilled alcoholic beverages, at the rate of 11 twelve dollars per gallon; 12 (7) wine at the rate of thirty percent ad valorem; (8) foodstuffs for human consumption, at the rate of 13 three percent ad valorem; provided, however, that fresh 14 15 and frozen fish and seafood, shall be at the rate of twenty five percent ad valorem; 16 17 (9) gasoline and diesel fuel, at the rate of five cents per gallon, provided, however, that collection of 18 19 the import duty imposed by this subsection shall be 20 suspended until September 30, 2010; 21 (10) laundry bar soap, at the rate of twenty five 22 percent ad valorem; and 23 (11) all other imported products, except those 24 specified above, at the rate of four percent ad valorem." 25
