A BILL FOR AN ACT

To amend Public Law No. 10-31, the Chuuk Recovery Loan Act, by amending Section 3 thereof to allow waiver of the one (1) percent annual interest if necessary to augment Chuuk State's capacity to implement its financial and structural reform program, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

| 1 | Section 1. Section 3 of Public Law No. 10-31, the Chuuk |

| 7 | October 1 thereafter through July 1, 2001; |
| 8 | (2) bear interest at the rate of 1% per year, payable |
| 9 | in arrears on each of the repayment dates for principal; |
| 10 | provided interest or payment thereof may be waived or |
| 11 | paid at a later date to be determined by FSM if FSM |
| 12 | determines that the State requires the accrued interest |
| 13 | or payment thereof for its financial and structural |
| 14 | reform progress; and |
| 15 | (3) be used solely for the purpose of repaying money |
| 16 | owed by the State for payroll allotments, FSM income tax |
| 17 | withholding, FSM social security taxes, offshore medical |
| 18 | referrals, and other purchases from abroad, which |
| 19 | repayments shall be made directly to the creditor by the |

| 1 | FSM. The funds appropriated herein from the General Fund |
