A BILL FOR AN ACT

To further amend Public Law No. 14-107, by amending Section 2 thereof, to change the use of certain funds previously appropriated for Yap State, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Purpose - a certain amount of project 1 2 appropriations lapsed on September 2006. The purpose of this bill is to appropriate from the general fund a corresponding amount. 3 4 The intent is similar to extending the lapse date of the 5 appropriations. 6 Section 2. The sum of \$421,110, is hereby appropriated from 7 the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2007 for the purpose of funding 8 9 public projects and social programs in the States of Chuuk, 10 Kosrae, Pohnpei and Yap. The funds appropriated under section 1 of this act shall be apportioned as follow: 11 12 1. State of Yap.....\$ 121,872 13 a. [Gargey Power, Water & Road **Projects**] Land acquisition for Outer Islanders 14 \$121,872 15 2. State of Chuuk..... \$11,004 16 a. Chuuk At-Large (i) Construction materials for 17 School building in Weno 3,300 18 19 b. Election District No. 5

19	Section 3. All funds appropriated by this act shall be
20	allotted, managed, administered, and accounted for in accordance
21	with applicable law, including, but not limited to, the Financial
22	Management Act of 1979. The allottee of the funds appropriated
23	in subsection 1 (a) of Section 1 of this Act shall be the
24	Governor of Yap State, PROVIDED HOWEVER, that the funding for
25	subsection 1(a) of Section 1 of this Act shall not be expended

1 until the allottee certifies that the Gargey area shall not be 2 used for commercial activities. The allottee of the funds appropriated in subsection 2 of Section 1 of this Act shall be 3 4 the Chuuk State Commission on Improvement Project (CSCIP). The 5 allottee of funds appropriated in subsections 3 and 4 of Section 6 1 of this Act shall be the President of the Federated States of 7 Micronesia or his designee. The allottee shall be responsible for ensuring that these funds, or so much thereof as may be 8 necessary, are used solely for the purpose specified in this act, 9 and that no obligations are incurred in excess of the sum 10 11 appropriated. The authority of the allottee to obligate funds 12 appropriated by this act shall not lapse.

Section 4. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
