

Public Law No. 15 03

AN ACT

To further amend Public Law No. 14-107, by amending Sections 2 and 3 thereof, to change the use and allottee of certain funds previously appropriated for Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose - a certain amount of project
2 appropriations lapsed on September 2006. The purpose of this bill
3 is to appropriate from the general fund a corresponding amount.
4 The intent is similar to extending the lapse date of the
5 appropriations.

6 Section 2. The sum of \$421,110, is hereby appropriated from
7 the General Fund of the Federated States of Micronesia for the
8 fiscal year ending September 30, 2007 for the purpose of funding
9 public projects and social programs in the States of Chuuk,
10 Kosrae, Pohnpei and Yap. The funds appropriated under section 1
11 of this act shall be apportioned as follow:

12 (1) State of Yap \$ 121,872

13 (a) Land acquisition for Outer Islanders,

14 PROVIDED THAT the title of the land purchased on Yap proper
15 and responsibility for administration of such land to be held
16 in Trust by the Council of Tamol of the Outer Islands for the
17 benefit of the people of the Outer Islands of Yap.... \$100,000

1 with applicable law, including, but not limited to, the Financial
2 Management Act of 1979. The allottee of the funds appropriated
3 in subsection 1 (a) of Section 1 of this Act shall be the
4 Governor of Yap State. The allottee of funds appropriated in
5 subsection 1 (b) of section 1 of this Act shall be the President
6 of the College of Micronesia - FSM. The allottee of the funds
7 appropriated in subsection 2 of Section 1 of this Act shall be
8 the Chuuk State Commission on Improvement Project (CSCIP). The
9 allottee of funds appropriated in subsections 3 and 4 of Section
10 1 of this Act shall be the President of the Federated States of
11 Micronesia or his designee. The allottee shall be responsible
12 for ensuring that these funds, or so much thereof as may be
13 necessary, are used solely for the purpose specified in this act,
14 and that no obligations are incurred in excess of the sum
15 appropriated. The authority of the allottee to obligate funds
16 appropriated by this act shall not lapse.


