# PUBLIC LAW No. 15-40

#### AN ACT

To appropriate the sum of \$245,000 from the General Fund of the Federated States of Micronesia, for the purpose of funding the national general election to take place in March 2009, and for other purposes.

#### BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Appropriation. There is hereby appropriated from
- 2 the General Fund of the Federated States of Micronesia the sum of
- 3 \$245,000, or so much thereof as may be necessary, for the
- 4 exclusive purpose of funding the national general election
- 5 scheduled to take place in March 2009.
- 6 Section 2. Reprogramming.
- 7 Funds appropriated in accordance with this act are not to be
- 8 subject to reprogramming.
- 9 Section 3. Allottee. The allottee of the funds appropriated
- 10 by this act shall be the President of the Federated States of
- 11 Micronesia.
- 12 Section 4. Allotment and management of funds and lapse date.
- 13 All funds appropriated by this act shall be allotted, managed,
- 14 administered and accounted for in accordance with applicable law,
- 15 including, but not limited, the Financial Management Act of 1979.
- 16 The allottee shall be responsible for ensuring that these funds,
- 17 or so much thereof as may be necessary, are used solely for the
- 18 purpose specified in this act, and that no obligations are
- 19 incurred in excess of the sum appropriated.

### PUBLIC LAW No. 15 - 40

1	Section 5. <u>Lapse Date</u> . The authority of the allottee to
2	obligate all funds appropriated under this act shall lapse as of
3	September 30, 2009.
4	Section 6. This act shall become law upon approval by the
5	President of the Federated States of Micronesia or upon its
6	becoming law without such approval.
