Dear Speaker Figir:

I have designated the following Congressional Act as Public Law No. 15-44.


Congressional Act No. 15-48, "AN ACT TO FURTHER AMEND PUBLIC LAW 15-32, AS AMENDED, BY AMENDING SECTION 1 THEREOF, TO CHANGE THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED FOR CERTAIN PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE STATES OF KOSRAE, YAP, CHUUK AND POHNPEI, AND FOR OTHER PURPOSES."

Note, however, that I have line item vetoed the following appropriations:

1. Section 1(4)(c)(iv) which proposed to zero-out the balance of this particular Section of Public Law 15-32, as amended. The fund balance under this Section is \$10,000 and is insufficient to fund the proposed uses; and
2. Congressional Act 15-48 proposes four (4) new projects under Section 1(4)(c) (xii-xv) and the funding for these new projects is insufficient as a result of the amendment to Section 1(4)(c)(iv).

Based on the Fund Balance Report indicating a balance of only \$10,000 in the account for Section 1(4)(c)(iv) and thus is insufficient to defray all purported uses, I regret to inform you of no other alternative but to line-item veto.

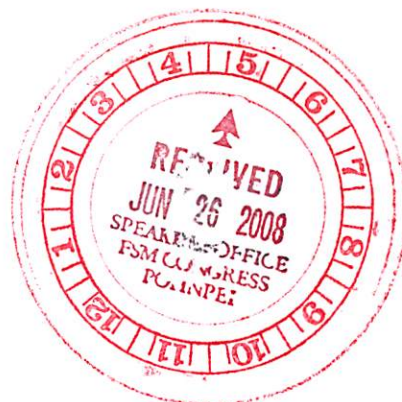

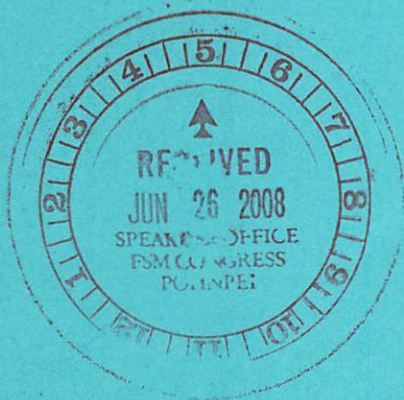



PUBLIC LAW No. 15-44

AN ACT

To further amend Public Law No. 15-32, as amended, by amending Section 1 thereof, to change the use of certain funds previously appropriated for public projects and social programs for the States of Kosrae, Yap, Chuuk and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-32, as amended by
2 Public Law No. 15-36, is hereby further amended to read as
3 follows:

4 "Section 1. The sum of \$3,780,000, or so much thereof
5 is hereby appropriated from the General Fund of the
6 Federated States of Micronesia for the fiscal year
7 ending September 30, 2008 for the purpose of funding
8 public projects and social programs in each State of the
9 Federated States of Micronesia. The fund shall be
10 apportioned on the basis of \$250,000 or less per member
11 of Congress as follows, PROVIDED THAT an increase of
12 \$300,000 is for Yap State.
