PUBLIC LAW No. 15 - 51

AN ACT

To further amend section 2 of Public Law No. 14-67, as amended, to change the lapse date of certain funds previously appropriated therein for each state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 14-67, as amended by

2 Public Laws Nos. 14-72, 14-82, 14-101 and 15-16, is hereby further

"Section 2. Allotment and management of funds and lapse All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979 and the amended Compact of Free Association between the United States Government and the Government of the Federated States of Micronesia and its related agreements. allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under subsections (4)(a), (c), (d) and (f) of section 1 of this act shall be the Chuuk State Commission on Improvement Project. The allottee of the funds

appropriated under subsection (4)(b) of section 1 of this act shall be the Mortlocks Development Commission. The allottee of funds appropriated under subsection (4)(e) of section 1 of this act shall be the Mayor of Polle. The allottee of funds appropriated under subsections 1, 2 and 3 of Section 1 of this act shall be the President of the Federated States of Micronesia except that the allottee of funds appropriated under subsections (2)(b), (2)(c), 2(d) and (2)(f) of Section 1 of this act shall be the Governor of the State of Yap. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2009."
