

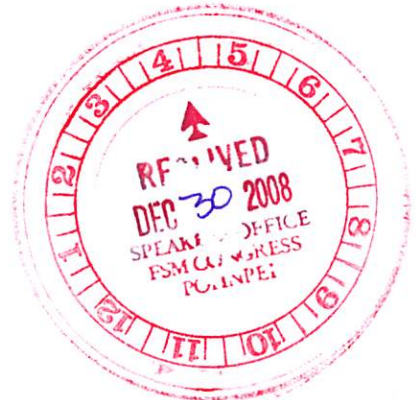

**PUBLIC LAW No. 15-62**

AN ACT

To further amend Public Law No. 15-25, as amended, by amending Section 1 thereof, to change the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 1 of Public Law No. 15-25, as amended by  
2 Public Law No. 15-35, is hereby further amended to read as  
3 follows:

4           "Section 1. The sum of \$366,255 realized from the 20%  
5 restricted funds previously allocated for Health and  
6 Education in Chuuk State and now lapsed into the general  
7 fund, is hereby appropriated from the General Fund of  
8 the Federated States of Micronesia for the fiscal year  
9 ending September 30, 2008 for the purpose of funding  
10 Public Projects in Chuuk State, and shall be apportioned  
11 as follow:

12	(1) Chuuk Public Utility Corporation.... \$	150,000
13	(2) Chuuk State Health Care Plan.....	123,875
14	(3) Health and Education related	
15	projects and programs.....	92,380
16	(a) Office Rental.....	20,000
17	(b) Road Pavement.....	22,000
18	(c) Medicine and medical	
19	supplies for Chuuk.....	1,300

5       Section 2. This act shall become law upon approval by the  
6 President of the Federated States of Micronesia or upon its  
7 becoming law without such approval.
