### AN ACT

To further amend Public Law No. 15-25, as amended, by amending Section 1 thereof, to change the use of certain funds previously appropriated therein, and for other purposes.

BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 1 of Public Law No. 15-25, as amended by
2	Public Law No. 15-35, is hereby further amended to read as
3	follows:
4	"Section 1. The sum of \$366,255 realized from the 20%
5	restricted funds previously allocated for Health and
6	Education in Chuuk State and now lapsed into the general
7	fund, is hereby appropriated from the General Fund of
8	the Federated States of Micronesia for the fiscal year
9	ending September 30, 2008 for the purpose of funding
10	Public Projects in Chuuk State, and shall be apportioned
11	as follow:
12	(1) Chuuk Public Utility Corporation\$ 150,000
13	(2) Chuuk State Health Care Plan 123,875
14	(3) Health and Education related
15	projects and programs
