

### **PUBLIC LAW No. 15 - 70**

#### AN ACT

Providing for the appointment of the FSM representatives to the Joint Economic Management Committee and the Joint Trust Fund Committee in accordance with the Compact of Free Association, as amended, between Federated States of Micronesia and the United States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Definitions. When used in this Act: 1 Section 1. (1) 'Compact' means the Compact of Free Association, as 2 3 amended, and its related agreements, entered into by and between the Government of the Federated States of 4 Micronesia and the Government of the United States, as 5 ratified on May 26, 2004. 6 (2) 'JEMCO' means the Joint Economic Management 7 8 Committee established pursuant to the Compact. (3) 'JEMCO Member' means a voting member representing 9 10 the Federated States of Micronesia on JEMCO. 11 (4) 'National Government' means the National Government of the Federated States of Micronesia. 12 13 (5) 'State' means a state of the Federated States of 14 Micronesia. 15 (6) 'Trust Fund Committee' means the Joint Trust fund 16 Committee established pursuant to the Compact." Section 2. Appointment and Terms of JEMCO Representatives. 17

(1) The President shall appoint, with the advice and

18

1	consent of Congress, two JEMCO Members;
2	(a) One member shall be appointed by virtue of
3	his or her position within the National Government; and
4	(b) The other member will be appointed by the
5	President from a list of four nominees, one nominee per
6	a state governor.
7	(2) The JEMCO Representatives must be citizens of the
8	FSM.
9	(3) JEMCO Members shall serve a two-year term, or
10	such other term as may be provided in the Compact. A
11	term shall commence from the date of confirmation by
12	Congress and end when respective replacements are
13	qualified and confirmed.
14	(5) A JEMCO member may be re-appointed for another
15	consecutive term, but not more than two consecutive
16	terms.
17	(5) The National Government will be responsible for
18	the cost of the representatives' participation in all
19	JEMCO meetings.
20	(6) The President may designate a temporary
21	substitute for any of the two representatives in the
22	event of temporary incapacity, illness, family
23	emergencies, and other reasons which prevent the advice
24	and consent representative from participating in JEMCO

businesses.

1	(7) A representative of the Federated States of		
2	Micronesia to JEMCO may be removed from office by the		
3	President for any reason.		
4	(8) A substitute representative of the Federated		
5	States of Micronesia to JEMCO shall not serve for more		
6	than three (3) consecutive months, unless he or she is		
7	first appointed by the President and confirmed by		
8	Congress.		
9	Section 3. Appointment and Term of Office for Joint Trust		
10	Fund Committee Representatives. The two representatives for the		
11	1 FSM Government to the Joint Trust Fund Committee Pursuant to Part		
12	2 III Article 7 of the Trust Fund Agreement of the Compact of Free		
13	3 Association, as amended, shall be selected as follows:		
14	(1) One will appointed by the President from a		
15	position within the FSM National Government related to		
16	law or finance, and the other one will be from the		
17	private sector with at least five years of working		
18	experiences in financial management and investment.		
19	Both appointments require advice and consent of the		
20	Congress. Both representatives shall serve for a term		
21	of three years each and may be reappointed to office for		
22	not more than two consecutive terms. Both must be		
23	citizens of the FSM during their terms of office.		
24	(2) The FSM National Government will be responsible		
25	for the costs of the representatives' participation in		

1	all Trust Fund activities. The President may designate
2	a temporary substitute for either of the representatives
3	in the event of temporary incapacity, illness, family
4	emergencies, and other reasons which prevent the advice
5	and consent representative from participating in Joint
6	Trust Fund Committee businesses.
7	(3) A representative of the Federated States of
8	Micronesia to JEMCO may be removed from office by the
9	President for any reason.
10	(4) A substitute representative of the Federated
11	States of Micronesia to JEMCO shall not serve for more
12	than three (3) consecutive months, unless he or she is
13	first appointed by the President and confirmed by
14	Congress.
