Dear Speaker Figir:

This Act amends Public Law No. 15-31 which appropriated the sum of \$342,000 from the General Fund of the Federated States of Micronesia for the Fiscal Year ending September 30, 2008 for the purpose to fund Public Projects for Pohnpei State. The purpose of this Act is to change use and amounts of certain funds for Pohnpei States projects resulting in increasing and decreasing the sum of certain line items.

It has become a routine practice to change the use and amount of funds previously appropriated for social projects and programs. While I fully support the idea of social and infrastructure development through funding of public projects and programs, I believe we should be extra careful with repetitive changes to appropriation law because such practice may implicate indecision of government planning and/or policy. Frequent amendment has a tendency to taint the original intent or policy of legislation. Moreover, it may in the eyes of the public points to weakness in government planning and decision-making. With these concerns, I transmit to you Congressional Act No. 15-83, which become Public Law No. 15-79 without my signature, entitled:
