

AN ACT

To amend Public Law No. 13-84, as amended, by amending section 1 thereof to change the uses of certain funds previously appropriated for Public Projects in Chuuk Election District No. 5, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 1 of Public Law No. 13-84, as amended by  
2   Public Laws Nos. 14-03, 14-36 and 14-63, is hereby further amended  
3   to read as follows:

4           "Section 1. The sum of \$263,222, or so much thereof as  
5           may be necessary, is hereby appropriated from the fund  
6           entitled 'Public Projects for Chuuk Election District No.  
7           5' within the General Fund, to provide funding for public  
8           projects in Chuuk Election District No. 5. The funds  
9           appropriated under this section shall be apportioned as
