# PUBLIC LAW NO. 15-69

#### AN ACT

To further amend Section 3 of Public Law No. 15-55 to change the use of funds previously appropriated therein from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, to provide funding for the operation of the Legislative Branch of the National Government of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 15-55, as amended, by 2 Public Law No. 15-55 is hereby further amended to read as follows: 3 "Section 3. Operating Expenses of the Legislative The sum of \$3,073,003 or so much thereof as may 4 Branch. 5 be necessary, is hereby appropriated from the General 6 Fund of the Federated States of Micronesia for the 7 fiscal year ending September 30, 2009, for the 8 operations of the Legislative Branch of the National 9 Government during fiscal year 2009. The sum 10 appropriated by this section shall be apportioned as 11 follows:
