A RESOLUTION

Extending the Presidential Emergency Declaration, and the State of Emergency established thereby, that was declared by the President of the Federated States of Micronesia on December 29, 2008 to respond to a disaster situation caused by tidal surges for an additional period of 15 days, and directing the President not to extend emergency food assistance beyond January 28, 2009.

- 1 WHEREAS, in December 2008 all four states of the Federated
- 2 States of Micronesia were affected by disasters resulting from
- 3 tidal surges, causing all governors to declare states of
- 4 emergency; and
- 5 WHEREAS, on December 29, 2008, in response to the Governors'
- 6 declarations, the President issued a "Presidential Emergency
- 7 Declaration" under section 9, Article X of the FSM Constitution,
- 8 41 FSMC Sec. 705 et seq., and 55 FSMC Sec. 610 et seq. whereby
- 9 "the resources of the National Government are committed to
- 10 supplement the available resources and action plan of the Four
- 11 States." Declaration page 1, last paragraph; and
- 12 WHEREAS, with the powers granted by the Declaration the
- 13 President has sent emergency food assistance to numerous outer
- 14 islands; and
- 15 WHEREAS, the immediate food assistance needs for the
- 16 emergency have abated, with the remaining tasks being long-term
- 17 mitigation, including replanting and restoration of the crop
- 18 system; and

        WHEREAS, such long-term activities are best dealt with in the

     framework of normal congressional appropriations and not through
 3
     emergency powers; and

        WHEREAS, government operations including emergency operations
 5
     should be transparent; now, therefore

        BE IT RESOLVED by the Fifteenth Congress of the Federated
 7
     States of Micronesia, Sixth Regular Session, 2009, that the
 8
     Presidential Emergency Declaration of December 29, 2008, and the
 9
     State of Emergency established thereby, are hereby extended for a
10
     period of 15 days so as to terminate on February 12, 2009; and

        BE IT FURTHER RESOLVED that the President is directed not to
12
     engage in additional expenditures related to emergency food
13
     assistance beyond January 28, 2009, and to concentrate instead on
     mitigation efforts that would continue after the termination of

     the State of Emergency; and

        BE IT FURTHER RESOLVED that the Congress exhorts the
17
     President to fully involve the four States of the Federated
     States of Micronesia and coordinate with them in the disaster

        BE IT FURTHER RESOLVED that certified copies of this

     resolution be transmitted to the President of the Federated

     States of Micronesia and the Secretary of Justice.
