

A BILL FOR AN ACT

To further amend Public Law No. 14-84, as amended, by amending sections 4 and 9 thereof, to change the use and lapse date of certain funds previously appropriated to fund public projects and social programs in the State of Yap, and for other purposes.

1 Section 1. Section 4 of Public Law No. 14-84, as amended by
2 Public Laws Nos. 14-96, 14-103 and 14-108, is hereby further
3 amended to read as follows:

4 "Section 4. The sum of \$561,476 or so much thereof as
5 may be necessary that lapsed as of June 30, 2006 or as
6 required by Public Law No. 14-35 from Public Laws Nos.
7 7-39, 8-19, 8-100, 8-115, 9-052, 9-095, 10-120, 10-143,
8 11-36 and 11-59 for the State of Yap, is hereby
9 reappropriated from the General Fund of the Federated
10 States of Micronesia for the purpose of funding projects
11 and social programs in the State of Yap, and is
12 apportioned as follow:

20 Section 2. Section 9 of Public Law No. 14-84, as amended by
 21 Public Laws Nos. 14-94 and 15-13, is hereby further amended to
 22 read as follows:

23 "Section 9. All funds appropriated by this act shall be
 24 allotted, managed, administered, and accounted for in
 25 accordance with applicable law, including, but not
 26 limited to, the Financial Management Act of 1979. The

1 allottee of the funds appropriated in Section 1 of this
2 Act shall be the President of the Federated States of
3 Micronesia or the President's designee, PROVIDED THAT
4 the allottee of funds appropriated in subsection (1) (f)
5 of Section 1 of this Act shall be the Governor of the
6 State of Kosrae. The allottee of the funds appropriated
7 in Sections 2, 3, and 4 of this Act shall be the Chuuk
8 State Commission on Improvement Project. The allottee
9 shall be responsible for ensuring that these funds, or
10 so much thereof as may be necessary, are used solely for
11 the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum
13 appropriated. The authority of the allottee to obligate
14 funds appropriated by this Act shall lapse as of
15 ~~September 30, 2008~~ September 30, 2009."

16 Section 3. This act shall become law upon approval by the
17 President of the Federated States of Micronesia or upon its
18 becoming law without such approval.
