

A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended, by repealing section 205 thereof, as enacted by Public Law No. 15-41, and enacting a new section 205, and by enacting a new section 167, for the purpose of clarifying the employees designated to receive the one-time salary increase intended by Public Law No. 15-41, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 52 of the Code of the Federated
2 States of Micronesia, as amended, is hereby further
3 amended by repealing section 205 thereof, as enacted
4 by Public Law No. 15-41, and by enacting a new
5 section 205 to read as follows:

7 The provisions of this schedule shall not operate to decrease
 8 the base salary biweekly rate of employees employed on the
 9 effective date of the amending act codified in this section.
 10 Furthermore, the base salary biweekly rate of such employees
 11 shall not be increased beyond the rate in effect on the
 12 effective date of the amending act codified in this section."

13 Section 2. Title 52 of the Code of the Federated States of
 14 Micronesia, as amended, is hereby further amended by enacting a
 15 new section 167 to read as follows:

16 "Section 167. One-time salary increase. To provide
 17 some relief to public service system employees holding
 18 lower salaried positions, a salary increase in the
 19 amount of \$35 biweekly is hereby provided public
 20 service system employees, who are not entitled to
 21 premiums pursuant to section 163 of this title, in
 22 addition to their biweekly salaries immediately prior
 23 to the date this act becomes law. This one-time
 24 compensation is provided, notwithstanding the salary
 25 freeze mandated in section 509 of this title and any
 1 other prior laws that may be in conflict with the

2 provisions of this section.

3 Section 3. Effective date. This act shall become
4 effective on October 1, 2008.

5 Section 4. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
