

A BILL FOR AN ACT

To amend Public Law No. 14-109 by amending Sections 2 and 3 thereof, to change the use and lapse date of certain funds previously appropriated therein for the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 14-109 is hereby  
2 amended to read as follows:

3 "Section 2. The sum of \$119,248 is hereby appropriated  
4 from the General Fund of the Federated States of  
5 Micronesia to fund public projects and social programs  
6 in the States of Chuuk and Pohnpei. The funds  
7 appropriated under Section 2 of this act shall be  
8 apportioned as follows:

5 Section 2. Section 3 of Public Law No. 14-109 is hereby  
 6 amended to read as follows:

7 Section 3. Allotment and management of funds and lapse  
 8 date. All funds appropriated by this act shall be allotted,  
 9 managed, administered and accounted for in accordance with  
 10 applicable laws, including, but not limited to, the Financial  
 11 Management Act of 1979 and the amended Compact of Free  
 12 Association between the United States Government and the  
 13 Government of the Federated States of Micronesia and its related  
 14 agreements. The allottee shall be responsible for ensuring that  
 15 these funds, or so much thereof as may be necessary, are used  
 16 solely for the purpose specified in this act, and that no  
 17 obligations are incurred in excess of the sum appropriated. The  
 18 allottee of funds appropriated under subsection 1 of Section 2 of  
 19 this Act shall be the Chuuk State Commission Improvement Project.  
 20 The allottee of the funds appropriated under subsection 2 of  
 21 Section 2 of this Act shall be the President of the Federated  
 22 States of Micronesia. The authority of the allottee to obligate  
 23 funds appropriated by this act shall lapse on [~~30 September,~~  
 24 ~~2008]~~ 30 September, 2009.

25 Section 3. This act shall become law upon approval by the  
 26 President of the Federated States of Micronesia or upon its

1 becoming law without such approval.
