

A BILL FOR AN ACT

To further amend section 1 of Public Law No. 14-67, as amended, to change the use of certain funds previously appropriated therein for Chuuk State At-Large, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 14-67, as amended by
2 Public Laws Nos. 14-72, 14-82, 14-91, 14-101 and 15-06, is hereby
3 further amended to read as follows:

4 "Section 1. The sum of \$2.1 million, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2006 for projects
8 and programs in each state of the Federated States of
9 Micronesia. The funds appropriated under section 1 of
10 this act shall be apportioned on the basis of \$150,000
11 per member of Congress as follows:
