A BILL FOR AN ACT

To further amend section 103 of title 36 of the Code of the Federated States of Micronesia, as amended by Public Law No. 15-75, to clarify the application of the 60-day period for submission of stock affidavit of an approved major corporation, to modify the FSM notary requirement, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1.Section 103 of title 36 of the Code of the

- 3 15-75, is hereby further amended to read as follows:
- 4 "Section 103. <u>Application for charter Article of</u>
- 5 <u>Incorporation</u>.
- (1) An association of persons seeking a charter as a corporation shall submit for approval of the President of the Federated States of Micronesia, or his designee, articles of incorporation which shall provide as least
- 10 the following information:
- 11 (a) proposed name of the corporation;
- 12 (b) principal office or place of business;
- 13 (c) proposed duration;
- 14 (d) purposes;
- (e) powers;
- (f) capitalization;
- 17 (q) names of incorporations, which shall be one
- 18 more;
- 19 (h) number of directors, which shall be one or

1	more, and proposed officers;
2	(i) name(s) of director(s) and officers to serve
3	until first election;
4	(j) provisions of management, if any;
5	(k) provisions for voting by members;
6	(1) provisions for shareholding, if any;
7	(m) disposition of financial surplus;
8	(n) provisions for liquidation;
9	(o) provisions for amendment of articles of
10	incorporation.
11	(2) A major corporation as defined under chapter 3 of
12	title 54 of the Code must submit [A] an affidavit shall
13	be submitted to the Office of the Registrar by the
14	President and Secretary of the corporation as named in
15	the articles of incorporation not later than sixty (60)
16	days from the date of receipt of the certificate of
17	incorporation. [The affidavit shall be notarized by a
18	duly authorized FSM notary.]
19	(3) The affidavit referred to under subsection (2) of
20	this section, and $[A]a$ ny other document $[(s)]$ that
21	requires notarization, shall be $[\frac{done}{}]$ notarized by an
22	authorized FSM notary or a notary public accredited by
23	the Registrar of Corporation."
