## A BILL FOR AN ACT

To further amend Public Law No. 14-84, as amended, by amending sections 4 and 9 thereof, to change the use, allottee and lapse date of certain funds previously appropriated to fund public projects and social programs in the State of Yap, and for other purposes.

1	Section 1. Section 4 of Public Law No. 14-84, as amended by
2	Public Laws Nos. 14-96, 14-103, 14-108 and 15-53, is hereby
3	further amended to read as follows:

The 2 allottee of the funds appropriated in Section 1 of this Act shall be the President of the Federated States of 3 4 Micronesia or the President's designee, PROVIDED THAT 5 the allottee of funds appropriated in subsection (1) (f) of Section 1 of this Act shall be the Governor of the 6 7 State of Kosrae. The allottee of the funds appropriated 8 in Sections  $2[\tau]$  and  $3[\tau]$  [and 4] of this Act shall be 9 the Chuuk State Commission on Improvement Project. The 10 allottee of funds appropriated in Section 4 of this Act shall be the Governor of Yap State. The allottee shall 11 12 be responsible for ensuring that these funds, or so much 13 thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations 14 15 are incurred in excess of the sum appropriated. The 16 authority of the allottee to obligate funds appropriated 17 by this Act shall lapse as of September 30, [2009] <u>2010</u>." 18 19 20 21 22 23 24 Section 3. This act shall become law upon approval by the 25 26 President of the Federated States of Micronesia or upon its
