A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending sections 630, 631 and 632 of subchapter VI thereof to modify the intent of the Fisheries Observer Revolving Fund and to increase the threshold amount in the Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 630 of Title 55 of the Code of the
- 2 Federated States of Micronesia, as enacted by Public Law No. 7-76,
- 3 is hereby amended to read as follows:
- 4 "Section 630. <u>Establishment</u>. There is hereby created
- 5 and established the Fisheries Observer <u>and Port Sampler</u>
- 6 Revolving Fund, separate from the General Fund of the
- 7 Federated States of Micronesia and all other funds."
- 8 Section 2. Section 631 of Title 55 of the Code of the
- 9 Federated States of Micronesia, as enacted by Public Law No. 7-76,
- 10 is hereby amended to read as follows:
- 11 "Section 631. Purpose. The purpose of the Fund is to
- 12 provide an ongoing revolving fund for the receipt and
- 13 disbursement of funds associated with the fisheries
- observer <u>and port sampler</u> programs as established by
- 15 sections $[\frac{118}{1}]$ 106(1)(b), 106(1)(c), $[\frac{404(2)(f)}{and}]$
- 16 606(1) and (606)(2) $[\frac{404(2)(k)}{2}]$ of title 24 of the Code
- 17 of the Federated States of Micronesia."
- 18 Section 3. Section 632 of Title 55 of the Code of the
