## A BILL FOR AN ACT

To appropriate the sum of \$350,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2010, for the purpose of providing funding for Infrastructure Maintenance Fund matching for the States of Yap, Kosrae, Chuuk and for furniture purchase for the State of Pohnpei, and for other purposes.

BE I	T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$350,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending
4	September 30, 2010, for the purpose of providing funding for
5	Infrastructure Maintenance Fund matching for the States of Yap,
6	Kosrae and Chuuk and for purchase of furniture for the State of
7	Pohnpei. The funds appropriated under this section shall be
