A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 11-81, 13-8, 13-78, and 14-81, by amending section 117 to exempt employees of the Project Management Unit for the Compact Infrastructure Grants under the Department of Transportation, Communication, and Infrastructure from the Public Service System Act, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 117 of title 52 of the Code of the
- 2 Federated States of Micronesia, as amended by Public Laws
- 3 Nos. 11-81, 13-8, 13-78, and 14-81, is hereby further amended
- 4 to read as follows:
- 5 "Section 117. <u>Application of chapter: Exemptions</u>.
- 6 The National Public Service System shall apply to all
- 7 employees of and positions in the Government of the
- Federated States of Micronesia now existing or
- 9 hereafter established and to all personnel services
- 10 performed for that Government except the following,
- 11 unless this chapter or provisions thereof are
- 12 specifically made applicable to them:
- 13 (1) Members of the Congress of the Federated States
- of Micronesia;
- 15 (2) the President and Vice President of the
- 16 Federated States of Micronesia;
- 17 (3) Justices and other Judges of the National
- 18 Courts;

(4) the legislative counsel, deputy legislative 1 counsel, director of administration and budget, budget officer, administrator and the clerk of the 3 4 Congress; (5) the Public Auditor; 5 (6) the administrative officer of the National 6 7 Courts: (7) the special assistants and secretaries to the 8 President and Vice President and the secretaries to 9 10 the Speaker and Vice-Speaker of the Congress of the Federated States of Micronesia; 11 (8) persons appointed by the President to fill the 12 following positions: Secretary of the Department of 13 Foreign Affairs, Secretary of the Department of 14 15 Finance and Administration, Secretary of the Department of Economic Affairs, Secretary of the 16 17 Department of Transportation, Communication and 18 Infrastructure, Secretary of the Department of Health, Education and Social Affairs, Secretary of 19 the Department of Justice, and the Chief Public 20 21 Defender, and their deputies, if any; (9) persons appointed to any other positions by the 22 President with the advice and consent of the 2.3 24 Congress;

(10) the Representative in Washington and all

ambassadors: 1 (11) persons or organizations retained by contract when the Personnel Officer has certified that the 3 4 service to be performed is special or unique and nonpermanent and is essential to the public interest, 5 and that, because of the degree of expertise or 6 7 special knowledge required and of the nature of the services to be performed, it would not be practical 8 9 to obtain personnel to perform such services through normal public service recruitment procedures; 10 11 (12) persons presently under contract of employment not included in subsection (11) of this section, 12 during the life of such contract. No contract of 13 14 employment shall be entered into, renewed, or amended 15 after the effective date of this chapter, except in accordance with the provisions of this chapter; 16 17 (13) temporary positions, required in the public interest, for which the need does not exceed six 18 19 months; (14) positions requiring part-time or intermittent 20 21 work which does not exceed sixty hours in any 22 calendar month; (15) positions filled by inmates, patients, and 2.3 students of institutions of the Federated States of 24 Micronesia: 25

1	(16) members of any board, public corporation,
2	commission, or similar body, in their capacity as
3	such;
4	(17) officers, faculty, and employees of the Board
5	of Regents and the College of Micronesia;
6	(18) positions specifically exempted by any other
7	law of the Federated States of Micronesia;
8	(19) all personnel of the National Weather Service,
9	provided that the National Weather Service shall be
10	administered by the Office of the President;
11	(20) all personnel of the Program Management Unit
12	for the Compact Infrastructure Grants under the
13	Department of Transportation, Communication and
14	<u>Infrastructure</u> ."
15	Section 2. This act shall become law upon approval by the
16	President of the Federated States of Micronesia or upon its
17	becoming law without such approval.
