Dear Speaker Figir:

Transmitted herewith is the following Congressional Act, which has become Public Law No. 16-21 without my signature.

Congressional Act No. 16-19, "AN ACT TO AMEND PUBLIC LAW NO. 15-31, AS AMENDED, BY AMENDING SECTION 1 THEREOF, TO CHANGE THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN FOR THE STATE OF POHNPEI, AND FOR OTHER PURPOSES."

As I shared to you before, in connection with Public Law No. 16-2 which was the amendment prior to this act, repeated changes in public project appropriations could be interpreted as indecision, or weakness, on our part as government planners and decision-makers. I also stated that while I do not oppose public projects, repeated changes in public project appropriation — the last amendment being 6 months ago - should be exercised with extreme caution to avoid the appearances that public projects are sheer politically-motivated. For this reason, I am compelled to allow this act to become law without signature.

I thank you and all the members of Congress for the time spent on this matter.



PUBLIC LAW No. 16-2/

AN ACT

To amend Public Law No. 15-31, as amended, by amending section 1thereof, to change the use of certain funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:								
1	Section 1. Section 1 of Public Law No. 15-31 as amended by								
2	Public Laws Nos. 15-54, 15-79 and 16-2, is hereby further amended								
3	to read as follows:								
4	"Section 1. The sum of \$342,000 is hereby appropriated								
5	from the General Fund of the Federated States of								
6	Micronesia for the fiscal year ending September 30, 2008								
7	for the purpose of funding public projects in the State								
8	of Pohnpei, and is apportioned as follows:
