AN ACT

To further amend Public Law No. 10-72, as amended by Public Laws Nos. 10-103 and 16-26, by amending sections 12, 13, 14, and 18 thereof for the purpose of increasing the effectiveness of meetings of the Board of Directors of Caroline Island Air, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 12 of Public Law No. 10-72 is hereby 1 2 amended to read as follows: 3 "Section 12. Board of Directors - Regular meetings. 4 Regular meetings shall be held not less than once per calendar quarter, at such times and place or places 5 as shall be determined in the bylaws. All voting 6 members of the Board, participating in a regular 7 meeting of the Board, are entitled to a meeting 8 9 allowance up to \$100 per meeting." Section 2. Section 13 of Public Law No. 10-72 is hereby 10 amended to read as follows: 11 12 "Section 13. <u>Board of Directors - Special meetings</u>. Special meetings shall be called by the chairman on 13 14 his own initiative, or by petition of two of the 15 members, pursuant to notice as shall be provided by 16 the bylaws. All voting members of the Board participating in a special meeting of the Board, are 17 entitled to a meeting allowance up to \$100 per 18

1	meeting. Nothing in this section shall entitle a		
2	member to a meeting allowance where a special		
3	meeting fails to fulfill quorum."		
4	Section 3. Section 14 of Public Law No. 10-72 is hereby		
5	amended to read as follows:		
6	"Section 14. <u>Board of Directors - Quorum</u> . A quorum		
7	for all regular business, regular meetings, and		
8	special meetings of the Board shall be three voting		
9	members."		
10	Section 4. Section 18 of Public Law No. 10-72 is hereby		
11	amended to read as follows:		
12	"Section 18. Board of Directors - Compensation of		
13	directors. All members of the Board shall be		
14	entitled to compensation for travel, per diem at		
15	established Federated States of Micronesia Government		
16	rates, and a meeting allowance when serving the		
17	Corporation."
