To amend Sections 1, 2 and 3 of Public Law No. 16-23, an appropriation for funding fiscal year 2010 economic and social projects and programs for the States of Kosrae, Pohnpei and Chuuk, by changing the use and allottee of certain funds previously appropriated therein for Chuuk and Kosrae States, and for other purposes.

1	Section 1. Section 1 of Public Law No. 16-23 is hereby

4	much thereof as may be necessary, is hereby appropriated
5	from the General Fund of the Federated States of
6	Micronesia for the fiscal year ending September 30,
7	2010, for the purpose of funding Economic and Social
