To authorize the President to submit the Recommended National Government Compact Budget Request, as revised pursuant to Congress' recommendations, to the United States under Article V of the Fiscal Procedures Agreement.

- 2 States of America have entered into a Compact of Free Association,
- 3 as amended; and
- WHEREAS, title 55 of the Code of the Federated States of
- 5 Micronesia, at section 103(4)(d), requires the President of the
- 6 Federated States of Micronesia to submit to Congress a Recommended
- 7 National Government Compact Budget Request for the ensuing fiscal
- 8 year; and
- 9 WHEREAS, title 55 of the Code of the Federated States of
- 10 Micronesia, at section 103(5)(b), permits the Congress, by
- 11 resolution, to recommend changes to the Recommended National
- 12 Government Compact Budget Request in any respect consistent with
- 13 the Compact, as amended; now, therefore,
- 14 BE IT RESOLVED that, Congress recommends the following
- 15 changes to the Recommended National Government Compact Budget
- 16 Request:
- 17 For the Education Sector Grant: reduce the total requested by
- 18 \$34,652, comprised of the following changes: increase the request
- 19 for COM to \$3,800,000 by requesting an additional \$123,597; reduce
- 20 the total requested for National Scholarship to \$350,000 by

1 reducing the requested amount by $250,000; delete the request to

- 2 fund "Bridging the Gap" contractual services of \$113,815; request
- 3 \$205,566 for former T-3 staff.
- 4 For the Sector Grant for Capacity Building: increase the
- 5 total requested by \$302,357, comprised of the following changes:
- 6 request \$174,357 for the Chuuk Branch of the Office of the Public
- 7 Auditor; request \$128,000 for the Tax Reform Project.
- 8 For the Public Infrastructure Sector Grant: reduce the total
- 9 requested by \$267,705, comprised of the following changes: delete
- 10 the request for multi-purpose building/medical warehouse of
- 11 \$600,000; reduce the request for COM-State campuses to an even
- 12 \$1,700,000 by reducing the requested amount by \$8,837; request
- 13 partial funding for Ms. Caroline Voyager dry-docking of \$341,132
- 14 (the net reduction resulting from Congress' other
- 15 recommendations).
- BE IT FURTHER RESOLVED that pursuant to title 55 of the Code
- 17 of the Federated States of Micronesia, section 103(7), the
- 18 President of the Federated States of Micronesia is hereby
- 19 authorized to submit the Recommended National Government Compact
- 20 Budget Request, in conformity with the terms of this resolution,
- 21 to the United States under Article V of the Fiscal Procedures
- 22 Agreement; and
