## A RESOLUTION

Requesting the President of the Federated States of Micronesia to give notice of the Federated States of Micronesia's withdrawal from the Third Implementing Arrangement to the Nauru Agreement unless the Arrangement is ratified and implemented by all parties without delay.

- 1 WHEREAS, the Federated States of Micronesia is a party to
- 2 the Nauru Agreement Concerning Cooperation in the Management of
- 3 Fisheries of Common Interest, hereinafter referred to as the
- 4 "Nauru Agreement"; and
- 5 WHEREAS, the purpose of the Nauru Agreement is to ensure
- 6 that the parties cooperate in the management of their
- 7 respective exclusive economic zones so that their citizens can
- 8 be assured of receiving the maximum benefits from their
- 9 resource; and
- 10 WHEREAS, on the 16th day of May, 2008, the Federated
- 11 States of Micronesia signed the Third Implementing Arrangement
- 12 to the Nauru Agreement setting forth additional terms and
- 13 conditions of access to the exclusive economic zones of the
- 14 parties, including a requirement that fishing vessels licensed
- 15 to fish in such zones be prohibited from fishing in the high
- 16 seas as a condition of their licenses; and
- WHEREAS, on the 19th day of January, 2011, the Sixteenth
- 18 Congress of the Federated States of Micronesia, Sixth Regular
- 19 Session, ratified the Third Implementing Arrangement by
- 20 Congressional Resolution 16-151; and

1 WHEREAS, other parties to the Nauru Agreement, namely

- 2 Kiribati, Papua New Guinea, and the Solomon Islands, have
- 3 apparently failed to ratify and implement the Third
- 4 Implementing Arrangement; and
- 5 WHEREAS, the Federated States of Micronesia is thus placed
- 6 at a competitive disadvantage with respect to the terms it can
- 7 offer in fisheries agreements; now, therefore,
- 8 BE IT RESOLVED by the Sixteenth Congress of the Federated
- 9 States of Micronesia, Sixth Special Session, 2011, that the
- 10 Congress requests the President to urge Kiribati, Papua New
- 11 Guinea and the Solomon Islands to ratify and implement the
- 12 Third Implementing Arrangement without delay; and
- 13 BE IT FURTHER RESOLVED that in the event the Third
- 14 Implementing Arrangement is not timely ratified and implemented
- 15 by all parties, the Congress requests the President to give
- 16 notice to the Depository of the Nauru Agreement of the
- 17 Federated States of Micronesia's withdrawal from the Third
- 18 Implementing Arrangement;
- 19 BE IT FURTHER RESOLVED that a certified copy of this
- 20 Resolution be transmitted to the President of the Federated
- 21 States of Micronesia.
