

A RESOLUTION

To confirm the nomination of Mr. Ricky Carl to serve as a member of the Board of Directors of the National Oceanic Resources Management Authority (NORMA).

1 WHEREAS, pursuant to section 201 of title 24 of the Code of
2 the Federated States of Micronesia, as amended by Public Law Nos.
3 12-34 and 15-38, the Board of Directors of the National Oceanic
4 Resource Management Authority (NORMA) is composed of five members;
5 and

6 WHEREAS, pursuant to section 201 of title 24 of the Code of
7 the Federated States of Micronesia, as amended by Public Law Nos.
8 12-34 and 15-38, the President of the Federated States of
9 Micronesia appoints one member from each State to serve on the
10 Board of Directors of NORMA, in consultation with the Governor and
11 with the advice and consent of Congress; and

12 WHEREAS, pursuant to section 201 of title 24 of the Code of
13 the Federated States of Micronesia, as amended by Public Law Nos.
14 12-34 and 15-38, the President has appointed Mr. Ricky Carl, an
15 appointee recommended by the Governor of the State of Pohnpei, to
16 serve as the Pohnpei State representative on the Board of
17 Directors of NORMA for two years; and

18 WHEREAS, Mr. Ricky Carl has experience and qualifications
19 which make him a suitable candidate to serve on the Board of
20 Directors; and

2 WHEREAS, pursuant to section 201 of title 24 of the Code of
3 the Federated States of Micronesia, as amended by Public Law Nos.
4 12-34 and 15-38, the appointment is subject to the advice and
5 consent of the Congress of the Federated States of Micronesia; and

6 WHEREAS, pursuant to section 201 of title 24 of the Code of
7 the Federated States of Micronesia, as amended by Public Law Nos.
8 12-34 and 15-38, board members are appointed to serve a two year
9 term; now therefore,

10 BE IT RESOLVED by the Sixteenth Congress of the Federated
11 States of Micronesia, Fourth Special Session, July 2010, that the
12 appointment of Mr. Ricky Carl to serve as a Member of the Board of
13 Directors of NORMA, be confirmed; and

14 BE IT FURTHER RESOLVED that certified copies of this
15 resolution be transmitted to the President of the Federated States
16 of Micronesia, the Governor of the State of Pohnpei, the Board of
17 Directors of NORMA and Mr. Ricky Carl.
