A BILL FOR AN ACT

To amend title 10 of the Code of the Federated States of Micronesia by adding a new chapter 7 to establish a Strategic Partnerships Commission, and for other purposes.

E I	T ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Title 10 of the Code of the Federated States
2	of Micronesia is hereby amended by inserting a new chapter 7
3	entitled <u>"Strategic Partnerships Commission."</u>
4	Section 2. Title 10 of the Code of the Federated States
5	of Micronesia is hereby amended by adding a new section 701 to
6	chapter 7 to read as follows:
7	"Section 701. Establishment of Commission. There is
8	hereby created within the Executive Branch of the
9	Government of the Federated States of Micronesia a
10	Strategic Partnerships Commission (hereinafter
11	referred to as the "Commission") which shall be under
12	the jurisdiction of the President and shall have the
13	following powers and duties:
14	(1) review the relationship of Free
15	Association with the United States of America and
16	explore the possibility of alternative relationships
17	with the United States and other strategic partners;
18	(2) advise and assist the President in
19	developing policies, plans, programs, and budgets for

2		(3) make recommendations to the President

3	Section 5. This act shall become law upon approval by the
4	President of the Federated States of Micronesia or upon its
5	becoming law without such approval.
