A BILL FOR AN ACT

To further amend section 203 title 2 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 10-55, 15-09 and 15-74, and by further amending section 204, as amended by Public Laws Nos. 10-55, 13-75 and 15-09, for the purpose of replacing the Department of Health and Social Affairs and the Department of Education with Executive Offices under the Office of the Vice President, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 203 of title 2 of the Code of the 1 Section 1. 2 Federated States of Micronesia, as amended by Public Laws Nos. 10-55, 15-09 and 15-74, is hereby further amended to read as follows: 5 "Section 203. Departments. (1) There shall be the following departments 6 7 which shall be responsible for major programs or administrative support areas in the Government 8 of the Federated States of Micronesia: 9 (a) Department of Resources and 10 11 Development; 12 (b) Department of Finance and 13 Administration; (c) Department of Foreign Affairs; 14 15 (d) [Department of Health and Social Affairs: 16 (e) Department of Justice; and

1 [f] (e) Department of Transportation, Communication and Infrastructure, which shall contain among other 2 3 units, a Project Management Unit for the Compact Infrastructure Grants; and. 4 [(g) Department of Education.] 5 6 (2) The administrative head of each department shall be designated as a "Secretary". (3) The administrative head of each office 8 9 shall be designated as a "Director". (4) Succession. 10 (a) Any reference to a previously existing 11 12 department, office or division thereof shall 13 apply to the appropriate successor entity. (b) Any reference to any office or 14 employee of an entity referred to in subsection 15 (4)(a) of this section shall be construed as 16 17 applying to the person holding the same or most 18 similar position in the appropriate successor entity." 19 20 Section 2. Section 204 of title 2 of the Code of the 21 Federated States of Micronesia, as amended by Public Laws Nos. 10-55, 13-75 and 15-09, is hereby further amended to 22 23 read as follows: "Section 204. Other Executive Offices. 24 There shall be the following executive offices: 25
