## A BILL FOR AN ACT

To appropriate the sum of \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, for the purpose of funding public projects and social programs in the four States of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. The sum of \$1,400,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, for the purpose of funding public projects and social programs in the four States of the Federated States of Micronesia. The funds shall be apportioned on the basis of \$100,000 per member of Congress as follows: Section 2. Of the sum of \$1,400,000 appropriated by this act, \$200,000 is apportioned for public projects and social programs in the State of Yap. 11 (1) State of Yap.....\$ 200,000 Section 3. - 18 The authority of the allottee to obligate funds appropriated by
- 19 this act shall lapse on September 30, 2015.
- Section 7. This act shall become law upon approval by the
- 21 President of the Federated States of Micronesia or upon its
- 22 becoming law without such approval.
